#### REPORTS FROM MANAGEMENT:

## FINANCE & HR MANAGER:

VanDyke reviewed an insurance quote from MCRCSIP for consideration by the board.

The quarterly meeting of the Northern Michigan Road Commission Finance & HR Association was held on March 26, 2024, at the Roscommon County Road Commission. William VanDyke and Austin MacDougall attended. The main topic was to learn about the CRA's MiRAD system.

VanDyke advised the board that eleven older computers have been identified as needing to be replaced by October of 2025, as Microsoft has announced that it will no longer support Windows 10 after that date. Discussion was held about how to phase these replacements in and exclude certain units that may no longer be necessary by October 2025.

Progress on the DNR gravel pit lease has been slow, but it should be finalized in the coming week.

## MANAGER:

CRA's 2024 Highway Conference and Road Show was very informative with educational breakout sessions, the most notable topics being contract negotiations and how to best accommodate constitutional auditors.

Amvets has requested that the deposit requirement for borrowing traffic control devices be waived for their Blessing of the Bikes event. The board feels that we need to enforce the current policy # 1065 requiring the deposit.

Discussion on how to proceed with the issue of turning drain commission responsibilities back over to the county.

Presented a letter from an attorney pertaining to a supposed abandonment of Gold Street in Yates Township. No such abandonment has occurred. The matter has been forwarded to Henn Lesperance PLC.

The Conservation Resource Alliance will be pushing the 24<sup>th</sup> Street culvert replacement project out to 2025.

Williams opened discussion on the possibility of digging gravel from the Hunt Pit in Iron's. After visiting the site, it would not be feasible at this time.

Williams will be coordinating with the USFS on the best locations to start clearing right of ways with the Fire Break Contract.

Williams outlined additional road improvements offered by the USFS through the Good Neighbor Authority.

## **ROAD FOREMAN:**

## MACDOUGALL -

Stump removal on the Sheperd Road and River Road projects is nearing completion so that grade work and gravel placement can continue. Crews have also been tree cutting, and patching potholes.

#### DAILEY -

Tree cutting and stump removal has begun on Queens Highway near 96<sup>th</sup> Street to widen the road in needed areas.

Planning on removing larger stones that have pushed to the surface of 84th Street (Stoney Lane) in Section 28 of Chase Township.

Stump removal on Hawkins Road in the Olga Lake area of Dover Township will need to happen before beginning grade work and gravel placement on both Hawkins and Saddler Roads.

Thanked the board for sending him to the CRA's 2024 Highway Conference and Road Show.

Preparations for the grade work and gravel placement on Lakola Road North of 8 Mile Road in Dover Township are wrapping up.

#### LFUSBY -

Leusby outlined the conditions of the current truck market that makes ordering future trucks difficult with impending emissions regulations and long lead times.

#### **OLD BUSINESS:**

Williams requested a closed session to discuss negotiations of a proposed lease agreement.
