#### MACDOUGALL -

Culvert failure on Saturday 7/19 on West Bass Lake Rd. There were no Road Closed Signs on Emergency Response Trailer, signs had to be gotten from Troutarama Event. That sign issue has been addressed and taken care of. Culvert has been replaced as of Tuesday 7/22.

One more day of Chip Sealing left for the year 2025, has done a couple full width seals on the east side of county, 5-foot-wide seals on the edges on the west side to cover more area. Has been pulling berm in places in the meantime.

Has some employees out in trucks blading gravel roads trying to get the chatter taken out of them since we had gotten a little rain.

Clay has been getting dug in hopes to clay some gravel roads before they are brined for final time this year.

DAILEY -

Claying State Rd starting from US-10 headed north.
